Hi Megan

Just an update on this situation.

The tenant was evicted with the use of bailiffs and Police on 13 March 2015 (for rental arrears).

Upon eviction, the property was tested and found to be contaminated with methamphetamine residue. The Asset Manager has received quotes for decontamination. We are currently considering options in terms of divesting the property or holding it.

The house is boarded up to ensure no one enters it given the potential health and safety risk, and we are organising to get the rubbish removed urgently.

The Senior Tenancy Manager has been in contact with the immediate neighbours to keep them abreast of issues. However, had not been in touch with s9(2) who lives a bit further up the street. The STM contacted s9(2)(a) yesterday who was happy to be contacted and satisfied that we will be attending to the issues asap, he also has her contact details in case he has any further concerns.
